

### **Environment Of HSTU**

Environment' is one of the more popular words in the management lexicon, most generally understood to be referring to 'something outside'. For any organization, the environment consists of the set of external conditions and forces that have the potential to influence the organization. In the case of Subway, for example, the environment contains its customers, its rivals such as McDonald's and Kentucky Fried Chicken, social trends such as the shift in society toward healthier eating, political entities such as the US Congress, and many additional conditions and forces.

It is useful to break the concept of the environment down into two components. The general environment (or macro environment) includes overall trends and events in society such as social trends, technological trends, demographics, and economic conditions. The industry (or competitive environment) consists of multiple organizations that collectively compete with one another by providing similar goods, services, or both.

Every action that an organization takes, such as raising its prices or launching an advertising campaign, creates some degree of changes in the world around it. Most organizations are limited to influencing their industry. Subway's move to cut salt in its sandwiches, for example, may lead other fast-food firms to revisit the amount of salt contained in their products. A few organizations wield such power and influence that they can shape some elements of the general environment. While most organizations simply react to major technological trends, for example, the actions of firms such as Intel, Microsoft, and Apple help create these trends. Some aspects of the general environment, such as demographics, simply must be taken as a given by all organizations. Overall, the environment has a far greater influence on most organizations than most organizations have on the environment.

The organizational environment is the set of forces surrounding an organization that have the potential to affect the way it operates and its access to scarce resources. The organization needs understand environment effective to properly the for management. Scholars have divided these environmental factors into two parts

- A) Internal Environment.
- B) External Environment.



- **A)** Internal Environment: The internal environment consists of the organization's owners, board of directors, regulators, physical work environment and culture. In the internal environment include strength and weakness of an organization. Trade union, Management, Current employee, Share holders etc.
- **B)** External Environment: In the external environment include opportunities and threats of an organization. In the external environment include legal, physical economic, technology, social, political, culture. The external environment consists of two layers. They are:

### 1) Task Environment: 2) General Environment.

- i) **Task Environment:** Task environment is composed of the specific dimensions of the organization's surrounding that are very likely to influence of the organization. It also consists of five dimensions: Competitors, Customers, and Employees, Strategic, Planners and suppliers.
- **ii) General Environment:** General environment is composed of the nonspecific elements of the organization's surrounding the might affect its activities. It consists of five dimensions: Economic, Technological, Sociocultural, Political-Legal and International.

### **Environmental Dimensions:**

Environments can also be characterized along dimensions that describe the organization's context and influence its responses. One perspective views environments as information flows and suggests that organizations need to process information to discover how to relate to their environments. The key dimension of the environment affecting information processing is information uncertainty, or the degree to which environmental information is ambiguous. Organizations seek to remove uncertainty from the environment so that they know best how to transact with it. For example, organizations may try to discern customer needs through focus groups and surveys and attempt to understand competitor strategies through press releases, sales force behaviors, and knowledge of key personnel. The greater the uncertainty, the more information processing is required to learn about the environment. This is particularly evident when environments are complex and rapidly changing. These kinds of environments pose difficult information processing problems for organizations. For example, global competition, technological change, and financial markets have created highly uncertain and complex environments for many multinational firms and have severely strained their information processing capacity. Another perspective views environments as consisting of resources for



which organizations compete. The key environmental dimension is resource dependence, or the degree to which an organization relies on other organizations for resources. Organizations seek to manage critical sources of resource dependence while remaining as autonomous as possible. For example, firms may contract with several suppliers of the same raw material so that they are not overly dependent on one vendor. Resource dependence is extremely high for an organization when other organizations control critical resources that cannot be obtained easily elsewhere. Resource criticality and availability determine the extent to which an organization is dependent on the environment and must respond to its demands. An example is the tight labor market for information systems experts experienced by many firms in the late 1990s.

These two environmental dimensions--information uncertainty and resource dependence--can be combined to show the degree to which organizations are constrained by their environments and consequently must be responsive to their demands. As shown in Figure 58, organizations have the most freedom from external forces when information uncertainty and resource dependence are both low. In such situations, organizations do not need to respond to their environments and can behave relatively independently of them. U.S. automotive manufacturers faced these conditions in the 1950s and operated with relatively little external constraint or threat. Organizations are more constrained and must be more responsive to external demands as information uncertainty and resource dependence increase. They must perceive the environment accurately and respond to it appropriately. Organizations such as financial institutions, high-technology firms, and health-care facilities are facing unprecedented amounts of environmental uncertainty and resource dependence. Their existence depends on recognizing external challenges and responding quickly and appropriately to them.

### In this Organization Organizational Environment Relationship:

The stake holders of this organization are students, Officers and support staffs

The organization moves very smoothly but sometimes face little political crisis. On the other hand teachers show their interest to the administration moreover the officers and support staffs also show this interest to the administration the effective administration.

The organization has a rules and regulations: According that the administration gives there (teachers, Officers & stuffs) facilities within the law. For the general requirement the most of the general students convinced by the administration (Students Affairs Section).

On the other hand sometimes it can be critical to manage the students who are directly involved with the parties.

### 1. External Environment of HSTU:

In the external environment include opportunities and threats of an organization. In the external environment include legal, physical economic, technology, social, political, culture. The external environment consists of two layers. They are:

- **A. Task Environment:** The task environment is usually the environment that most organizations like to focus on. The task environment is very helpful to the organization because it helps them to specifically identify environmental factors that are important in the company's success. This environment is made up of five parts. The Task environment of HSTU are described below:
- i. **Competitors:** Competitors compete mostly for customer's money. For example HSTU, SSTU, and NSTU all University compete for student's that are looking for quality of education, hall facility etc. Organizations also compete against one another but not only for customer's money, but also for things like the right to buy a piece of real estate, or for a loan if the bank has limited funds they can lend.
- ii. **Customer:** The second part is customers. Organizations have individual customers as well as wholesalers, retailers, and schools that are also customers to companies. But as an Educational Institute, the main source of customer of HSTU is students.
- iii. **Suppliers:** The third part is suppliers, the ones who provide resources to other organizations. HSTU buys their all educational and official equipment from suppliers, and ketchup from Govt. Most companies don't buy ALL their supplies from just one supplier, because if that supplier goes bankrupt then so does the company that relied completely on them.
- iv. **Strategic Partners:** The fourth parts are strategic partners. This means that two companies work together in order to help each other. HSTU have collaboration with different international University for student and research exchange. This can help University get expertise from other University that they tend to lack in. In this environment the Chairmen will be able to see what other University or students help them and who they need to focus their advertisement on.



v. **Regulators:** The fifth part is regulators. Different regulatory body are involve such as Govt. Tax, Law and Enforce body etc.

### **B.** The General Environment of HSTU:

The general environment could be looked at as - social, cultural, legal, political, economic, technological and physical. These could be depicted in the following diagram

- **Social Sector** This involve the class structure, demographics, mobility patterns life styles of HSTU, and traditional social institutions like educational system, religious practices etc.
- **Cultural Sector** This includes the issues of history, traditions, expectations for behavior, and the values of the society or the society in which the organization operates of HSTU.
- **Legal Sector** This include the constitution and laws of the nations in which the organization conducts his business, as well as legal practices in each of these domains. HSTU have own rules and authority for University conduction.
- Political Sector- This describes the distribution and concentration of power and the nature
  of the political systems in those areas of the world in which the organization operates.
  Different Student Political Intuition involves such as: Chattra League, Chattra Dol and
  others.
- **Economic Sector** This includes numerous markets like the labor, financial, market for goods and services for HSTU. This tends to have a very powerful influence on conditions in the other sectors that we discuss here.
- **Technology Sector** This provides the knowledge and information in the form of scientific developments that the HSTU can acquire and use to produce output.
- Physical Sector This covers the nature and natural resources of HSTU.

### 2. Internal Environment:

The internal environment consists of the organization's owners, board of directors, regulators, physical work environment and culture. In the internal environment include strength and weakness of an organization. Trade union, Management, Current employee, Share holders. An organization's *internal environment* is composed of the elements within the organization, including current employees, management, and especially corporate culture, which defines employee behavior. Although some elements affect the organization as a whole, others affect only the manager. A manager's philosophical or leadership style directly impacts employees. Traditional managers give explicit instructions to employees, while progressive managers empower employees to make many of their own decisions. Changes in philosophy and/or leadership style are under the control of the manager. The following sections describe some of the elements that make up the internal environment.



Of course an organization is more than a collection of responses to the external environment. The ways people in an organization behave, including the goals they set and the manner in which they treat their customers, are also shaped by forces within the organization. These forces, which include an organization's culture and its climate, are sets of conditions that influence the decisions and behavior of employees at all levels of the organization. On a day-to-day basis, an employee's experience of an organization's culture and climate may feel hard to sort out, much as your experience of a hot summer day may result from a combination of your region's climate and the day's weather, or your experience of happiness from a combination of your general personality and your mood in response to recent events.

- **i. Organization's Owners**: As an autonomous organization, the main owner of HSTU is state. But it is conducted through the under control of Govt. policy.
- **ii.** Board of Directors: The Detail Board of Directors is shown in the table 1.1.

- **iii.** Organization Culture: One of the most important factors that influence an organization's response to its external environment is its culture. *Organization culture* is the set of important assumptions about the organization and its goals and practices that member of the company share. It is a system of shared values about what is important and beliefs about how the world works. In this way, a company's culture provides a framework that organizes and directs people's behavior on the job. The culture of an organization may be difficult for an observer to define easily, yet like an individual's personality, it can often be sensed almost immediately. For example, the way people dress and behave, the way they interact with each other and with customers, and the qualities that are likely to be valued by their managers are usually quite different at a bank than they are at a rock music company, and different again at a law firm or an advertising agency. In general, cultures can be categorized according to whether they emphasize flexibility or control and whether their focus is internal or external to the organization.
  - Group culture: A group culture is internally oriented and flexible. It tends to be based on the values and norms associated with affiliation. An organizational member's compliance with organizational directives flows from trust, tradition, and long-term commitment. It tends to emphasize member development and values participation in decision making. The strategic orientation associated with this cultural type is one of implementation through consensus building. Leaders tend to act as mentors and facilitators.
  - Hierarchical culture: The hierarchical culture is internally oriented by more focus on
    control and stability. It has the values and norms associated with a bureaucracy. It
    values stability and assumes that individuals will comply with organizational mandates
    when roles are stated formally and enforced through rules and procedures.

- Rational culture: The rational culture is externally oriented and focused on control. Its
  primary objectives are productivity, planning, and efficiency. Organizational members
  are motivated by the belief that performance that leads to the desired organizational
  objectives will be rewarded.
- Adhocracy: The adhocracy is externally oriented and flexible. This culture type emphasizes change in which growth, resource acquisition, and innovation are stressed.
- **iv. Employee:** Employee is also main functional body of an organization. HSTU is an autonomous body and it has its own employee rules and regulation.:



Getting information from international affairs section I am analyzing the status of international student. This analyzing and findings are below





Table-1: Total number of foreign students from 2010 to 2016





Table-2: According to gender




**Graph-2: According to gender**



**Table-3: According to Country** 




**Graph -3 According to Country** 


Most of the students have come from Nepal. The total no. of Nepali students are 108. The second highest students came from Somalia are 26. Third highest student came from Nigeria are 7.

**Table-4: According to SAARC Country** 




**Graph-4: According to SAARC Country**




**Graph-5: According to Continent** 

# **Interpretation:**


Most of the students have come from Asia. The Asian students are 111 and African students are 34. Unfortunately there are no students from Europe, North America, South America and Australia.

**Table-5 According to year** 




Graph-6: According to year



There are one thousand and forty five international students studding now within the students I have selected 16 students randomly. They have shown their opinion by the questioner. I have ensured the students from six countries.




**Graph-1: Education**


**Graph-2: Residence Facilities:**




**Graph-3: Foods (Bangladesh)**




**Graph-4: Administration:**
